



In this edition, our Role Model, Mallam Yusuf Ali took us down the memory lane, revealed the iron rods and raft that built him into a strong tower and he shed light on many thorny paths he walked to reach the citadel as he talked to our publisher, Lanre Olusunmade. Excerpts below:

We are here on a special interview with you on a special publication that we have dedicated to you as our Role Model of the year. Sir, I will start my question by asking, Ghalib is an Arabic name which means Victory. Why did you name your legal firm Ghalib?

Hmmm! May Allah rest the soul of my late wife. When the idea of setting up an office came up in 1994, I got home and we started discussing and said, "Look, can we start looking at names that we would name the office? The name was an idea of my late wife. Ghalib – victory in everything you do in life. Professionally, we always pray for victory, even socially, we pray for victory and even economically, we pray for victory, and in religious matters, we pray for victory.

So, the name was suggested by your late wife? Yes!

May almighty Allah bless her soul Amin!

You were once to be appointed the Minister of Justice and Attorney-General of the Federation but you turned it down

The offer came twice but I turned it down

Tell us what really transpired ... why you never accepted the offer?

Well, I think I know myself more than any other person and I know that I do not possess the talent or the ability of being a politician and since I don't have that kind of gift for a political appointment, it's better that I just keep-off; I should not be a part of anything I cannot make any difference. You'll hardly make

any difference in Nigerian politics especially when you are a subordinate. A minister is a subordinate to somebody. Making a difference is not easy when you have a principal.

Don't you think you can make an impact ... perhaps, change the narrative by occupying that position?

Well, it won't bring the kind of change you really desire. Democracy is about numbers; the minority will have their say and the majority will have their way. I have my own ideas of what Nigeria should look like but by being a Minister, you can't do much – no matter your views and visions because you are responsible to a principal who has his own vision and mission of what the country and what he wants as the President. So, being answerable to the president and his vision is a great barrier to effecting your desired change. Your plans and visions must align with that of the president in order to gain ground and from my study of the office since independence, rarely few people have been able to make impact there. Unfortunately, the office has been losing a shine progressively. I mean you can't compare the likes of Teslim Elias of blessed memory to some other people who have occupied the office. You are better off not going to a place that will mess you up. Whatever little

just resign and go away in peace. So, the best option is, if you cannot carry out the assignment your own way, don't venture into it because the people from your village, your mother's side, your father's family, your grandparents' lineage will start mounting pressure on you that you are wasting their slot, quote and unquote. My sense of being an Attorney General is an office that should be absolutely professional, that people should not be appointed based on politics or where they come from but from legal considerations and

qualifications. If I wanted to accept the position of Attorney General, I would insist that you cannot nominate me from any State. I want to be the Attorney General of the Federation, not a nominee from a certain state in the country who has to lobby senators from his place, lobby his state governor, and if issues that affect those places come up in his office after appointment, he will not be able to deal with them fairly. The bottom line is that somebody who should be Attorney General in a country like Nigeria should be somebody who should be begged to take up the position, not somebody who is begging for it. That's the only way we can get out of the problems.

As a lawyer, in what ways will you say the position of Attorney General of the Federation has been to some extent, bastardized in recent times? It has always been a controversy of the separation of the office between the office of the Attorney General which is the number one officer of the land and Minister of Justice. I have never subscribed to that. I know in our country you are just going to start promoting and provoking more fights in the cabinet

A Brilliant Man with a Giant Vision

n the history and propagation of Islam, three people were integral part of faith – Khadija Rosulullahi, the wife of Prophet Muhammed (SAW) who is the first woman to accept Islam, Abu Bakr, a merchant and friend of Prophet Muhammed. He was the first man to accept Islam and the last but not the least is Sayyidina Alli, the first boy or youngster to accept Islam.

This young chap, Sayyidina Alli (RTA) was said to be a brave warrior who fought in many Jihad battles and emerged victorious – though not without wound and bruises. This young lad was also recorded to be a son-in-law of this revered prophet as he was married to the beautiful daughter of Prophet, Fatimah, and they were both blessed with a set of twins – Hassan and Hussein. Alli was also the last Khalifa, who pushed Islam deeper than any other person in history.

Mallam Yusuf Ali can be likened to Sayyidina Alli, a strong man of faith. His undaunted faith in Allah is like a string that keeps his heart glued to his body and his belief in Prophet Muhammed and tenets of Islam are the strong pillars that shape his life and disposition.

Mallam Yusuf Ali is a man with many features – a brilliant lawyer, an Arabic scholar, a philanthropist, an aristocrat, a professional to the core, a family man, a visionary and a Moslem. As a man of principle, he might appear too tough for certain loafers but only an animal on a suicide mission will challenge a lion to a duel. The king of the jungle will never tuck his tail in-between his laps and turn his back to run away from any beast. Something in his DNA, since he was a cub has been telling him – "You are the lion … you are the jungle king … you should roar, not bark like a dog … you should hunt for prey … "Lions do not feed on dead animals; they kill and eat fresh animals.

Mallam Yusuf Ali's rise to the top is not a roller coaster, prices were paid to win the coveted prize. He endured pain to gain prominence. There were several nights of sleepless nights in cold weather without blankets to shield his body from the sharp needles of storm. He had low moments, high moments, crying period and of course, moments of joy and laughter.

my NYSC to serve at the old Kwara State. We were just about 15 lawyers in my set, and all of us were posted to the Ministry of lustice.

In those days, lawyers were not posted to private chambers. From the Ministry of Justice, we were reposted to various sections and strata. I was posted to the Judiciary where I was attached to the Late Honourable Justice Iduba Obayan who was at that time number 3 or 4 in the Hierarchy of High Court of Justice in the State. It was while I was there, that I made up my mind to either stay in llorin or go back to Ibadan and practise. I knew I won't be so occupied as such. I wanted to have the experience of practice in Northern Nigeria and Kwara being part of the North is an ideal place to start.

I approached Mr. Adegboyega Awomolo, now Asiwaju Adegboyega Awomolo, SAN, if I could be perching and learning in his office. Whenever I closed at the judiciary, I would go to his office in the evening. Along the line, I started resuming in his office because there wasn't much for me to do in the judiciary. I virtually did my NYSC in his office, though not official. After my NYSC, I continued in that office to actualise my own plan of learning Northern practice, and the rest is history. I was with him for 11 years before I started Ghalib Chambers on the Ist of June 1994 in a rented 3-bedroom apartment at Taiwo Junction until I became a Senior Advocate of Nigeria in 1997 when we acquired a piece of land for this office in 1998/99.

This building (referring to the structure where the interview was *conducted*) is a twin. The other portion is about 12 years old. We moved in 2001 September or so,

as God enabled us.

Now, let me take you back a bit; after your secondary school; where did you work briefly?

I was a clerical officer in the old Oyo State Ministry of Finance. I was posted to Igbo Ora as a Clerical Tax Officer, Igbo Ora near Eruwa.

After primary school one would have expected you to expressly proceed to secondary school but you did not.

Well, that's the disadvantage of living with an old person. When we were in primary school, we were not aware that entrance examination has to be taken to proceed to upper basic school. I was living with an old woman who knew next to nothing about educational system, except that my uncle (my father's cousin) was the headmaster of a modern school nearby. I didn't write any entrance exam into the school, they just took me in in 1969. At that time, modern school guaranteed entry into Grade 2 Teacher Training Colleges. It afforded one to become a Grade 2 teacher which was one of the best professions at the time.

Being a teacher was a great achievement and I was actually ready to go all the way for it. As a matter of fact, I gained admission to Wesley Teacher Training College, Ibadan in 1971 but I was rejected because of my small stature. That refusal was the reason I had to work.

When you eventually made up your mind to study Law; what was the reaction of your father that wanted you to study Agric?

I'm fortunate with the kind of parents I had. My father, may God

rest his soul, died in 2017 at about age 90. My dad would support whatever good decisions you make. He wanted me to read Agric because he was a technician at the Institute of Agric Research and Training, Ibadan. He had witnessed several fresh graduates of Agric employed after him who later became his boss. He was nursing the ambition that his son would read Agric and become other people's fathers' Oga (boss). When I could not read Agric, I eventually settled for Law. My father was glad and I'm sure he never regretted allowing me to become what God created me to be.

You were a powerful debater in secondary school; was that one of the reasons or motivation for choosing Law?

I think so; I have been debating for my school since Modern 2 and taking part in quiz competition. Modern School in those days was extra 3 to primary years. In secondary school, I was in the same class with people who had just left primary school, who were just 11 or 12 years old when I was already 18 years. Here is my point; I was already matured by the time I entered the university – and that gave me an advantage because in modern school I was a Prefect who would not allow students to speak Yoruba but English Language. That also polished my communication skill. Violators were fined half a penny. Our spoken English is more eloquent than that of our classmates in secondary school. I could read newspapers very well and to the glory of God, we won most of the guizzes and debates we did. I was participating in debates until I got to class 5 when I stopped to fully focus on the preparation for my WAEC final exams.

of the federal government because you are going to discover you know the kind of silence that goes on between senior ministers and junior ministers in the government quarters. We are going to create the same problems. The problem is not about the office being fused into one, it is about the occupants. Teslim Elias was the Attorney General of this Federation and the Minister of Justice of this country. So, it's about the character, the nuances, the value system of whoever occupies the position not only Attorney General – but any office, even the President. It's the value of the person who is there. These two things happen to an office when an individual gets there; if he's a man of high standards, he will bring it to his own standard but if he's a man of low standard, he will bring the office down to meet his own standard. I think there has been too much politics in offices than it should be, and I think being the Attorney General of the Federation is far more important than the Minister of Justice. It appears there is a confusion about the office now. I don't agree that the office has been bastardized, it's just that we are talking about standards and quality of service.

In your own view, what do you think is the way out?

As I mentioned earlier, the office of the Attorney- General in a third world country like Nigeria should not be given to somebody who is looking for it, it should be given to somebody who could be appealed to: that's number one. Number two; that office is not a place where people go to make name, it should be an office where people who already have good names should be. It is an office to

be reserved for somebody who has something to defend in terms of integrity, in terms of good names and goodly heritage, in terms of achievements and professionalism to occupy. It's not an office where people should now go and start looking for achievements and accolades. Do you get my points? The position should be reserved for people who are virtually readymade professionally. People who can look at the President in the face and tell him this is the position of our constitution, you cannot do



this. It must be somebody who holds a lot of respect from other minsters because that is the only office that our constitution prescribes professional qualification, no other minister is said to be this or that. It is only the Attorney General who must be a lawyer, who must not just be a lawyer but must have a lot of experiences post his call to the bar. The constitution also prescribes the number of years that the Attorney General must have spent in practice.

Even though, it's a primus enterprise, first among its equals. It is really the only office you are appointed by way of your professional calling, where the qualification is already stated in the constitution. From councillorship to becoming the president or minister in this country, all you need to show is the evidence of attendance of a secondary school – and that does not mean you must pass, it only says evidence of attendance. It doesn't mean you must have six or five credits, and it goes on to say that equivalent of it is that if you have attended primary school and you have some experience, it could be rated as an equivalent of school certificate. So, any other person can be in any other ministry and be the president or the vice president once you have the evidence of attendance of a secondary school but you cannot be Minister of Justice and Attorney General. It requires more for that office than the certificates; it should be for people who have achieved professionally, who is not looking for any new thing to conquer professionally. It is not the kind of office where you now go to make a name. It is not for the people to say, "Oh, he's a lawyer ... we didn't even know because he has been doing some other things." It's an office that must be given to somebody who is very seasoned in most areas of law, and very importantly litigation. I think those are the issues.

For the sake of the project; let's know more about you, who is Mallam Yusuf Ali, your name, where you were born and your professional history?

Thank you. I was born in the early 50s. I started school in 1960. I did my primary school the same time



with Arabic school. I lived the early part of my life until I was about 15 or 16 with my paternal grandmother at lfetedo, Osun State. I attended Ansar-ul-Deen Primary School and Local Authority Modern School in Ifetedo. I left in 1971, moved to Ibadan to join my parents. I worked briefly, then entered secondary school in 1973. At that time, I was more than 18 years old. I went to Ibadan Boys' High School and finished in 1977. 1 worked briefly before I gained admission into The Polytechnic, Ibadan to read Mass Communications. I spent just a few weeks there before gaining admission into the University of Ife to read History (Education), which I did not apply for. We were the first set of students in Nigeria to take JAMB in 1978. I took the offer, spent one year at the university reading History (Education) but my ambition was to read Law. By the way, let it be known that in 1977, I was given admission at the University of Ibadan to study Agric,

which was my father's greatest desire for me. I also got admission to the University of Ife to read Law during the time of consensus examination because at that time, each university conducted its own exams. I couldn't go to UI because WAEC withheld my Chemistry result, even though I did well in my consensus exam. I remember UI was willing to admit me with ordinary P7 in Chemistry because of my performance in the consensus exam. University of Ife on the other hand gave me admission letter a week after matriculation. With boldness garnered from being a very matured student, I went to the Registrar, asked if it was possible to defer my admission till the following year, but they said it was impossible as the matriculation had already been done and no new students can be admitted after matriculation day. I pleaded further but it was already too late, it was not the usual practice and besides, a new exam

module has just been introduced by JAMB.

I settled for History at Ife with the determination to change to Law. I thank God, I did very well in my First Semester exam. I think I got A in all my papers and the people in the Faculty of Law said, "Oh, we will gladly take this fellow if he performs this well in the second semester. He will join us via direct entry."

At the end of it all and to the glory of God, I did very well. Law was willing to take me but Education History wouldn't release me for the fear of losing their best student to another faculty. I remember that the Late Thomas Faiana was the Dean of Education in Ife in 1979 and the man said he won't release anybody for another faculty, that they cannot be releasing their best students to go somewhere else.

In the interim, Late Professor Sanni of Chemical Engineering Department who was an old student of Ibadan Boys' High School and my father's friend advised me to take a new admission form if I could not change from History (Education) to study Law. He said I would only lose a year but I will satisfy my conscience. I took another IAMB form as counselled with the determination to secure Law admission and start from 100 Level. I gained admission to study Law in 1979 and God who was at work at the time is still at work to date and till forever.

One day, I was in the mosque praying after scoring over 300 in AMB, awaiting Law admission letter into 100L, and I prayed thus, "Oh Allah, if you allow this change of

course to come through, I will be better dedicated to your course than before. I will be more involved in religious activities than just going to Mosque to pray." Although I have been observing complete Salat as a young person since 1972 but that very day in 1979, I struck a deal with Allah. The university system in those days was run in such a way that new students would resume ahead of returning students, complete their registration and do matriculation, but in 1979, old students came back before the new students because JAMB was being perfected.


I resumed in school and returned to History, at least, to while away time while expecting new intakes to join for the commencement of 100 Level – but on a Friday like that, I went to the mosque Juma'ah service, somebody called me and said, "Ali ... Ali, there is a change of course list posted on the faculty notice board." I asked, "What about it?" He said. "You are the number one on the list. You have been allowed

to change from History to Law." I said, "That's not possible because

> the Dean said he won't allow anybody to change. " I got to the notice board. Lo and behold!, my name was number one from History Education to Law, I was allowed to change without using the JAMB result to enter for Law. I crossed over, direct, to Law 200 Level. What I lost initially, God restored supernaturally – and due to my performance in the 100L, I became the University Scholar and Federal Government Fellowship Award Winner, with a conditional rule that states, 'You must not fail, or score

below a minimum standard or change course except the faculty you are moving from expressly agree that you can use the scholarship with the fellowship,' or else, you will lose it. So, the people in education said, "Shebi, you are going to Law Department; if you are that brilliant, go and take your fellowship there, we won't allow you to use our Fellowship Award elsewhere." That was how they denied me the opportunity to transfer the fellowship from Education to Law but Alhamdulillah, my first year in Law 200 Level, I won the Fellowship again – and all through my years in the university, I was a University Scholar and Fellowship Award Winner and the worth was a lot, about 650 naira ... enough money to buy a Tokunbo car in those days.

I didn't lose anything after the crossing over, I graduated with Second Class Upper in 1982. I went to the Law School in Lagos and also graduated with a Second Class Upper. I was called to Bar in July 1983, and from there went for



Group of Schools. It was confirmed that Hajia had passed on, and I arranged for her to be buried in our house which was under construction at the time. I described the exact spot where her tomb would be to them and there she was interned. Her death, and that of the school mates were the reasons why the two dates are indelible; one in Ife as a student and as a family man.

May almighty Allah bless her soul. Amin!

Sorry sir, 'E ku a temo'ra' {Take heart}, Alhamdulilah. We thank God that the children came out alive.

We thank Allah for her soul and the lives of the kids. But why have you not remarried after her death?

Don't go there please. It's a topic I don't like to discuss.

Is it a personal decision?

It's Allah's decision. You can't do anything except what Allah wills. After your NYSC in Ilorin, most people would have expected you to practise in more developed cities like Lagos or Ibadan. Why did you stay back in Ilorin?

That's the act of God. I have two other lawyer friends, Honourable Adebayo Shittu, former Communications Minister, he's my friend though my senior at the bar, and there was another friend, we

lost him in February or March, AbdulSalam Tunde Abbas, the former Chairman of Ejigbo Local Government in Osun State who was also my senior.

The three of us wanted to set up a partnership; Honourable Shittu had acquired an office at a complex opposite BCOS (Broadcasting Corporation of Oyo State) in Ibadan – and we had even made a partnership agreement and I was ready to go back to Ibadan for the commencement of the partnership but Awomolo just called me one day and asked, "Won't you like to stay around and practise in llorin here?" I was also thinking through same path but I didn't know how to go about it and Ibadan stuff was

Another profession you had passion for was Mass Communications/Journalism which you later practised as an undergraduate and you rose to become an editor of a newspaper

(Cut in) I was the editor of Touch Newspaper at the university.

But why did you leave Poly Ibadan then ... is it because you were determined to study Law?

No... no, not that. Everyone knows the distance between having HND and Degree. I don't want to run into that gap, and since I had the opportunity to go for the best, why should I settle for less. It was

everybody's dream in those days to go to University of Ife. It will be unwise for me to reject that offer.

The first day you stepped your feet in Ife; what was the impression like? Well, the first time I stepped into Ife campus was in 1977 when I went to see the registrar. I took my exams there. When I gained

environment. It is alluring, inviting, friendly and it matches with nature. In those days, there were no bukaterias, only the cafeteria system and not many Nigerians know that it was General Buhari that cancelled

admission wasn't my first time.

the cafeteria system in 1984 when he was the military Head of State and the reason he stated was that the students were agitating for food and that was how we lost the cafeteria system in our schools.

Let's have your experiences at the University of Ife when the school was great lfe, not OAU.

Ife in those days was the hotbed of the very best you get as an undergraduate. The academic competition was very stiff and speaking about Law, we had the set of best lecturers you can ever imagine as tutors – from our Dean to graduate assistants. We had array of seasoned professors, doctors and learned lecturers. Students

were well behaved and people knew their rights. We had enlightened studentship and cultured union. During our elections, tribunals would be set-up to address issues raised by dissatisfied candidates, and correct anomalies. Petitions were handled and scrutinised by Law students who were engaged as lawyers – and the process was always interesting. Student life, for me, was awesome. I was able to keep the promise I made to God after crossing over from Education to Law Faculty, I became a very serious moslem student activist.

Did you ever involve yourself in student activism?

No! I was a moslem student; my activism was within the MSS. In fact, I was the one that pioneered the setting-up of MSS at Ibadan Boys' High School but I wasn't serious with Islamic affairs as I did during my university days. I was deeply involved to the point of becoming the Chairman of lihad Week and later the President of MSS in Ife. Zonal PRO, national PRO, Zonal Vice President and later the Vice President for the whole of Southern Nigeria. It was quite a journey of promise and fulfilment – a strong compliant to the pledge I made to Allah, and that was the turning point for my life.

Can you recall an experience you had as a student of Ife that you can't forget in a hurry ... that remains indelible in your heart?

It was the death of four students in 1982 ... the death of Adebimpe and three others. It cannot be erased from my memory because I had become the President of MSS at the time and I was very popular and proactive among the students. Due to my popularity, students

were mounting pressure on me to become an executive member of the Students' Union Government. The President and Secretary of the Student Union consulted me for support on pressing issues. A day before the demonstration that led to the unfortunate death of these students. I saw Fatima Adebimpe, a Moslem sister. She was very close to me. I also told my fellow MSS sisters and brothers not to demonstrate the next day because the police would not know how to handle the students - and like I had a premonition of what was going to happen. I pleaded with them not to join the solidarity march but to remain safe on campus, do our own solidarity there before we all dispersed to our hostels.

I didn't know Fatima and her friends, one of them is now an associate professor were part of the protest. Nobody could ascertain the number of people that died but it was an indelible memory because people kept calling on me as the president to confirm the whereabouts and status of Fatima but I was just telling them to calm down that everything would be fine. I assured the people that Fatimo would be found hale and hearty. The next day after the demonstration, I went to the teaching hospital and visited the morgue. Lo and behold, I saw her dead body.

Fatima had gone; she was wearing a trouser and a white top. I remember that image clearly. The next problem was how to break the sad news to our members. We returned to the campus, everyone was waiting for me, quite a number of them were waiting around the student Union Building, more than 100 people and I said, "Please, let's

go back to the Secretariat of the MSS. So, I went to Fajuyi Hall where the Secretariat was, and luckily it was almost time for lunch, I said to them, "Fatimo has some minor injuries but she'll be okay." I encouraged all of them to go for lunch at the cafeteria because I was sure the news would eventually be broken to them but I did not want them to receive the news on an empty stomach, or we would have more casualties. All of us ate our lunch; we were talking and I was smiling to cover the anguish in my heart and so on and so forth. At 4pm, we all gathered at the Congress where the Student Union leaders would be able to address the students and give them situation reports – and right there, they broke the news to the people, mentioned the names of the four students who died in the mishap and Fatima Adebimpe's name was also mentioned. I will never forget that incident. Another sad event that broke my heart was the death of my wife. We lost her in a ghastly motor accident.

Was it in Ilorin here?

Yes. It was on a Sunday; I was traveling to Abuja for the NBA national conference in 2004. It was in August and I remember she was sleeping when I was leaving because she was fasting – and as her usual practice, she always slept after Salat in the morning. I was to drive myself but I needed to bid her farewell, so, I woke her up and she saw me into my car. In her presence, I entered the car and drove off – but around 2:30 or 3pm, my friend, Oloyede, the present Registrar of JAMB called my GSM line when I was close to Gwagwalada on the way to Abuja on Lokoja Road saying. "Arakunrin,

where are you?" I answered, "I told you I was travelling to Abuja for NBA meeting.'

"Okay! Who is with you?" He asked further.

I said: "my driver" and he said, "Please, give the phone to the driver." I wondered what was happening but I handed the phone over to my driver who became more confused after hearing the message. I felt uneasy and lost demanded to know what the problem was. Meanwhile, I'd totally forgotten a friend was traveling with me.

My wife, Kenny was taking our daughter who was attending a private secondary school, doing extra mural class in preparation for her final examinations to Offa in her Benz car. Her twin sister's son. Abdullahi who had just gained admission to Obafemi Awolowo University, Ile-Ife, visited us and he joined her on the trip to Offa, and my niece, Shakira was also in the car. My wife and daughter sat in front whilst Abdullahi and Shakira sat on the back seat. Oloyede broke the news that, "Haiia had an accident!" I asked him what the situation was and he responded she was undergoing treatment at the hospital. I stood on my faith in Allah as a Moslem and demanded to know what happened exactly. I ordered my driver, Koboko, to turn back, that we are heading home, "Alhaja is dead!" We entered a petrol station, he made a U-turn as I guestioned his ability to drive fast or hand the wheel over to me. I kept trying to reach Professor Oloyede as we were heading back home but he wasn't picking his phone. I called another friend, Aliu Badmus, who is the owner of Igra

now. Boys want to make money by killing girls, using body parts to make money. It wasn't like this when we were growing up; hard work was celebrated but not anymore. Honesty was celebrated but not anymore. Decency was celebrated but not anymore. I learnt what is trending now is that girls are sleeping with dogs for money ... that's bestiality under the law. It's a criminal offence. Bestiality is what people are now celebrating in the society. Those are the things scattering our value system.

Value degradation cuts across all professions in the society; we all worship at the altar of materialism. In the profession, younger people coming up are not thinking of hard work as a means of achieving their set goals; they are looking at "oga" riding a Rolls Royce, and wondering why they can't have their own now. They forget that 'ogas' paid their dues. I started riding a car with a Passat that I bought for 1,500 naira. It was a second-hand car. The first coloured television we had as a couple was bought in instalments. I am not ashamed to say it because I got married two months after NYSC. If my wife was alive, she would have been 65 this year. I got married on a salary of 300 naira a month and the first fridge we used was a gift my father-in-law gave to my wife in 1982 when she graduated from University of Ife. When we wanted to buy a freezer in those days, it was 1,050 naira. I paid the money more than eight times. I am not ashamed to say it because I didn't come from a wealthy family. My father was a poor civil servant and my mother was a trader, now she's about 90. The message is, if Allah could do it

> for me, he could do it for any other person. So, people should not despise a little beginning and we should not be too much in a hurry. The first house I bought, I took a bank loan to secure it and I spent two-three years to renovate it.

But some of these young people had argued that despite the fact that you are earning 300 naira at that time, the economic value was strong.

Who is receiving 300 naira these days? Let's stop making excuses; what 300 naira would buy in those days is what its equivalent will buy today. Even if these people who are professionals at making excuses are to be paid N3 million per day, they won't still do anything meaningful with their resources. Stop wasting time by talking to those people who are saying that money has lost value. In those days, young lawyers charged 100 naira to bail somebody. Young lawyers now charge thousands of naira to bail

people now. Those who could buy brand new cars from their earnings are the same set of people that can buy brand new cars from their earnings now. There is no magic about it, when people say this thing, l just laugh. 300 naira was also peanuts in those days but we survived because we lived within our means. Which lawyer would charge one million naira in those days? Are you getting my point? To write letters in those days, we took between 100 and 150 naira. I am very sure that any lawyer will not take that ridiculous amount now.

But despite this gloomy picture, what is the way out?

It's not gloomy. I think it's for us to just go back to the beginning by putting our values right. If we are able to stop public immoralities, stop looters of public funds and fight bribery and corruption, we will be better. Corruption has become our norm. If a petrol attendant is appointed a commissioner today, he will control a fleet of cars in the next six months. How come? How can that happen in a decent society and they will not cry out? Churches and mosques are aiding corruption in some ways because they don't guestion the source of monies brought to the church and mosques by the people. We need to ask where and how the money donated at social functions is got. People often ask me about the problem of Nigeria and I often reply that we Nigerians are the problem of Nigeria. The problem of Nigeria is you and I. If we want to have a decent society, we will have it by our joint decisions and convictions.

Elections are around the corner; people will be expecting the contestants to give them money

already on track. He urged further and I began to see reasons why staying is better than leaving. I made up my mind to stay, I told the other guys about my intention to stay in Ilorin. They moved on without me and when I told my father about my plan to stay in llorin, he was very happy about it and all I can say is that Allah orchestrated everything and it happened according to His plan.

You became a Senior Advocate in 1997, how has it really impacted on your professional career?

It's tremendous when you operate from the zenith; it is different from operating from below. The highest rank you can ever attain in law is Senior Advocate of Nigeria. It has broadened my outlook, broadened my professional influence and broadened so many things about me. It has been a blessing, a professional blessing, a spiritual blessing, it has been a blessing all through. Alhamdulillah! I know on a personal level that it is a call to better services, harder assignments and that's the way it has been with me.

In the course of your professional calling, you have won some landmark cases. How do you feel when you won those cases? Any case we win, I feel good because I put my best into it and if God rewards my best with victory, I will be happy. Of course, I have always been very happy when we win.

Which one of your cases has been the most challenging?

All the cases I handled are so challenging; I don't take any matter lightly. All cases that come to me I take them as if it's the only thing that is left; there is no case that is

not challenging, it depends on what you want to do with it.

Now, let's go back to when you started your practice; what were the initial challenges you faced, and why did you not want to partner with Mr. Awomolo?

I think everything hangs on destiny. Partnering with Awomolo was the initial plan but it didn't work out as planned. Let's leave it that way. I had to leave but we parted on the best brotherly and friendly basis, there was no guarrel at all, not even a disagreement and we are still very close as brothers till date. The initial challenge I will never be ashamed to say is that the first two years rent of 24,000 naira I paid was borrowed. I wasn't prepared to leave; it just happened and I had no savings and no plan but God has been very kind and faithful to me.

Looking back now, how fulfilled are you to have taken that decision? Like I told you, all I want to do is just for me to keep on thanking God every second of my life that he directed my steps aright, not only in that decision but in every other decision I'd taken.



Sir, if one has reflected on your journey through life, one area that most people thought you would have gone into which you never moved into is partisan politics. Why don't you go into partisan politics? I think I have answered that before.

I told you I don't have talent for it. I can't say something and act contrary. I call a spade by its name, that's number 1.

Number 2, I can't bribe people to serve them. How will I sit down here, do my work, make some little money and use it to bribe the voters I plan to serve. I can't do that; if I say I want to serve, I really want to serve. I can't bribe people because I want to serve them and I can't be lying to them.

What are your guiding principles in life?

Faith in Allah: absolute faith in Allah. I am an unrepentant optimist, full of integrity, honesty and some degrees of high morals. Nobody is perfect; we all have our feelings but anything hangs on morals. I avoid cheating and practise good neighbourliness and brotherliness. I believe the society will be better if

we all play our little roles there. I try to assist people as much as I can in any way possible, be it materially, morally or socially. A man who is fulfilled and has everything – food and clothes – will not be happy seeing his neighbours hungry or naked.

Why Mallam before Yusuf Ali, SAN, despite the title?

Because Mallam is not an intricate title; it means learned. So, if people say you are learned, what are you looking for again?

But I learnt you have been offered chieftaincy titles; why did you decline?

That's not my own way. I like to remain who I am. That is one of the reasons I don't want to take any ministerial position because it has a way of changing who you are. I want to remain who I am, a private person who is also approachable.

Philanthropy is one aspect of your life. As a matter of fact, you set up a foundation for that. What was the motivation behind that?

Well, I think it's Allah. I always tell people that if God does not give you a giving spirit; no matter what you have, you won't give out a dime. I want to thank my parents, my late wife and my children for supporting me. If I had 20,000 naira and I wanted to give out, my parents would not say no, my late wife would not say no and my children will not say no. They encouraged me to give and assist other people. If the people close to you do not want you to give, it will have negative effects on

you. God has been very kind to me by giving me a generous heart and the people who keyed into the vision. Philanthropy is good but immediate family support is very important.

How would you describe your personality?

I am a humble servant of Allah who tries at all times to meet the expectations of Allah, the creator in all circumstances - professional, spiritual, social, private and public.

Aside your faith, what is the most important thing to you?

Back to your profession; you've delivered over 200 papers; which one is your most favourite?

All of them! I do a lot of intellectual

thinking and works and I put so much effort into collating the information and don't forget, each one addresses different needs, topics and different urgencies depending on the audience. It is very important to understand the audience too well before getting information and putting the findings together. I want you to know that all the papers I presented are intellectual properties ... and very important to me.

What life lesson do you hold on to?

Do unto others what you want them to do unto you. Things you know you don't want people to do to you, don't do to them. If you don't like me to cheat you, don't cheat me or people the way you want me to be treated; do not lie to others or be dishonest to them. Be truthful, factual, reliable and responsible.

Looking back to when vou started, which aspect of your life would you say you could have changed?

I was too rascally as a youngster. I don't have anything to hide about it. I say it anywhere; I was a bit stubborn. That was the aspect of my life I would love to correct if I could turn back the hands of time. My stubbornness was as a result of the environment I grew up in, an environment where you need to prove your boyhood by your prowess but luckily the society has changed for better now.

How were you able to sustain your clients over the years?

I deal with people equally without compromising my integrity. Anybody who hires us knows that his matter cannot be handled with kid gloves, we don't compromise or deal negatively against you, no matter what is involved and people know that we are committed. Once we accept a matter, we will pursue it to its logical conclusion and we try to give quality service and importantly, we counsel you based on our own understanding and our professional position. If a matter is not worthy to be pursued, we will tell you but if it is worthy to be pursued, we put in our best and if it's a case of 50-50, we will also advise you. There have been instances when some clients were advised not to pursue certain matters and they pursued the cases and lost. Cases from high court to Supreme Court, and importantly, we don't just take cases because money is involved. We look at the ethical rules around it. If it fails the ethical rules of the profession, we will not take it and if it fails my own moral standard as a person, I won't take it. Everything is not about money. When are you planning to retire?

Well, insha Allah, may God spare our lives. In this business, we hardly retire. There is no point retiring but I'm praying that if Allah stretches my

life till 75, I'll scale down tremendously.

Do you have a succession plan? I understand one of your children also studied law.

My succession plan is not about family; it's about building a model where generations to come will meet the office in existence, not necessarily because your children are there. Incidentally, I have this discussion with somebody in my house. I said, "I am not building this firm as a family enterprise." It's an enterprise for everybody and I know that very soon, we will have a number of partners who can fly the flag higher. I am not an inward driven person. I believe there are big firms, built all over the world, that are still existing after hundreds of years – and that's my own view of what the Law Firm should be and by the grace of God, that's what I'm working towards.

Amen! For the sake of this project, which centres on the younger ones, what will you say is responsible for the low mind-set of the Nigerian youth? The breakdown of value system and family system, our values have gone to the dust. We celebrate material acquisition at the expense of morality, at the expense of what is good and decent. When somebody flaunts money, nobody asks about the source of the money. But as a rich man, the person has become a hero. That's not right, the society will not make progress and you will see the level of ritual killing going on









before they can vote. If you have sold your franchise, how can you complain that somebody is not doing something good when he gets into the office? Changing Nigeria to a good and enviable country is a task for all of us. Some of us can stand and criticize the people in the government because I have not compromised in any way – even at the NBA level, people collect money to vote for people. So, what are we talking about; if at a professional level, the ill act is perpetrated, then who is righteous enough to criticise the larger society when the micro citizens they represent is also corrupt? People don't like hard talk but we have to say it if we want the society to be upright. We must be upright. All it takes for a street to be clean is for every occupant to sweep the frontage of his own house. You sweep your own and I sweep my own but it won't work if Kenny sweeps his own frontage, and you clean yours but I refuse to sweep mine, dumping a pile of rubbish in front of my house ... the mess from my own end will mess up the entire street and it will look untidy. They may be saying the frontage of your house is clean, Kenny's own is clean but my own has just become a nuisance. We don't need the knowledge of rocket science to be decent. Some of the banditry going back and forth are reactions to some of the madness going on in our society; get rich quick syndrome.

In the good old days, children must not be seen with items their parents did not buy for them but these days, how many parents speak against their children using expensive gadgets like iPhone X or ask questions to straighten things? There's moral decadence

everywhere. In those days if you travelled to your village with a bicycle, people would say you left just one year ago, how did you get the bicycle?. They would ask questions. Today, petrol attendants venture into politics and take government appointments, and a year after, they have private jets and nobody is asking questions. The fault is ours, all of us – journalists, lawyers, accountants, and ordinary people on the streets. We are all contributing to the woes of Nigeria. If we all stand up against moral failure, Nigeria will become a better state. Look at the case of America and Donald Trump; if it had happened in Nigeria, the country would have gone silent but they have strong



heckmate the excessiveness. What we call institutions are human beings that made the institutions. Trump would have become a dictator and tyrant but the system did not allow him.

Sir, what is your advice for the younger ones?

I want them to know that the only place where wealth comes is work. They have to work hard to obtain material things. You don't look for material things first and then look for job to support it; it is the other way round. So, my advice is that we should make a living with our hands and our heads. Handwork doesn't kill. One

thing I have discovered on a spiritual claim is, if you work hard, God will bless it but if you cut corners, God will not help you to sustain it. Ile ta fi to mo, iri loma n wo, eyan o de le taja epe ko gb'owo erin. (Anything you build by cutting corners will not last).

If you smile into the mirror, it smiles back at you, and if you frown into the mirror, it frowns back at you. That's life! The younger people in our country should know that running away is not the solution. Our forebears were forced into slavery, now we are walking into slavery by ourselves just because there is light there. When our own best brains are running away, who will make sure that things are working in this country? I had the opportunity to go to Canada in 1988. I said no, what am I going to do in another man's country? I will be a third class citizen. They may give you the papers but you are not part of them. You can never be. Allah has a purpose for putting you here, and not there. We should build this nation by not doing illegal things. People want to use electricity without paying bills; how's that possible? In the places where they are all running to, you pay with your sweat to sustain electricity in your house. When you subsidize service not production, you will run into trouble like we are running into. Subsidize Agric, let's farm, food will be cheap. You are not subsidising transportation by not paying economic rate on fuel and doing so is subsidising a few people. Unfortunately, our labour unions are not honest with the people. They just state their popular views and people are still suffering.

On a final note, what do you want to be remembered for?


I want to be remembered as humble servant of Allah who came to this world, served Allah and humanity to the best of his ability.

She had her nursing training at the School of Nursing, UCH where she worked briefly before gaining admission into the University of Ife (now Obafemi Awolowo University) for BSc in Nursing in 1976. She graduated in 1983 for her NYSC in Kwara State where she later served at the School of Nursing as a tutor, before establishing a pharmaceutical store, and later general merchandise - retailing and wholesales in llorin.

Hajia Kehinde Ali got married to her heartthrob, Mallam Yusuf Olaolu Ali, SAN on 28th of October 1984 and the marriage was blessed with four beautiful kids.

The Genesis of a Blossomed Marriage

Kehinde and Ali were students of the University of Ife and active members of the Muslim Students Society of Nigeria. Ali, being the coordinator and Amir was quite popular among the students and so familiar with the Moslem ladies.

The chemistry between the love birds jelled faster because during holidays, Ali, as a good leader, made it a point of duty to conduct visitation to members' houses – although, nothing spectacular, just brother and sister relationship, until Ali was in his final year in 1982 and like a child's play, he proposed to Kehinde in plain but funny way, no rings, no kneeling down or fanfare, in Yoruba language. "Sister Kenny, will you consider marrying me?"

Kenny looked at one small Alfa in probably a three-quarter trouser and over-worn shirt, (but saw a Prince in the shining armour) – and all the while she x-rayed her hubby, the Mallam was bewildered, wondering why he had to end a good friendship and respected association in such a manner.

Number One; Ali once encouraged Kenny to marry a brother who had earlier showed interest, and was relying on him to

mediate - she refused the first suitor.

That day, Kenny said "Yes ... I live with you till I breathe my last." She later confessed to Ali, "When you were asking me to marry Brother XYZ, I thought, 'Is this guy out of his mind?' You have known all my family. God saved you for asking me." In 1982, formal introduction was done. Kenny's father consented, the entire family agreed – and the rest was history. In October 1984, the Nikkah was performed before the cloud of witnesses and they lived happily ever after.

The Modern Wife of Old Tradition

Kenny was an exceptional human being – a wife and mother, a friend and confident. To her husband; she was an answer to prayer, a companion that attracts like a magnet. To her mother-in-law; Kenny was a prized daughter and gist partner. When Hajia Kehinde died, her mother-in-law fainted and Mama's regular visit to llorin stopped.

To Ali's siblings; *Hajia Kehinde was a mother and sister.* Ali's younger brother that lived with them for about 10 years confessed, "*For 10 years that I lived with you guys, there was no single day I had anything ill to complain about this woman.*" To friends and neighbours; *Hajia was an angel in human body.* Her kitchen was a public domain. Her food basket was for every hand to scoop as much as possible. Her love for giving and aiding the ailing and needy is unparalleled.

She was a gentle dove that lived with an impatient Man like Yusuf, and she was the sheep that tamed the impatience out of him. She was a role-model to newly wedded wives and inspiration to old wives.

Hajia was Mallam Yusuf Ali's banker and financial advisor. She was the motivating oil in Mallam's success engine and the pillar that spurred him to keep going. So appreciative and considerate, she was the catalyst that made Ali's love for mankind to keep blossoming and jellying. In fact, most of the things Olaolu does today were the wife's dream.

Mallam's Attestation:

"I bought a car for her at a time and she suggested, 'Why don't you give this car to Barrister , one of your associates (*I won't mention the person's name*) – and I did. There was also a time I wanted to buy a CRV costing I million naira (*a lot of money at the time*) for her. She thanked me for the good gesture and told me, "Why do you want to give me a car when you have just started a housing project? Divert the money into the project." (The place where this interview was conducted).

"She was very accommodating and tolerant; there is quite a number of people who are not related to us by blood that became our children, sisters, brothers or friends. I have a distant niece, now retired, but working as an engineer in a federal government parastatal then. One day, my wife asked me for money but I told her, "*I don't have*," – and when the lady, very close to my wife came complaining of being very broke, my wife said to her, "Why don't you talk to your brother? He told me there was no money this morning but with your own complaint, he might do something." I eventually assisted the lady who later told me. Another woman wouldn't have mentioned that."

The Major Experience

When Mallam Yusuf Ali applied to be SAN in 1997, Hajia Kehinde was the prayer warrior. If she was asked to fast for 2 or 3 days for the children, she would fast three days for each child and do another three days for her husband.

"The day they were having the Privileges Committee meeting for the appointment of Senior Advocates, she stayed indoor for two days to pray and fast, and when the appointment was made, my phone (no GSM at the time) was faulty. She received the news from one of our elders in the privileges committee who called the house number, and she sent our niece living with us to me. I could not drive that day – in order to avoid accident for being over-excited." Mallam Yusuf Ali said.

Hajia Kehinde's Influence on the Kids

The major thing Hajia taught the kids was love for Allah and observing the fundamentals of Islam – so, she would ensure that they performed their salat as at when due – especially when their dad was away on official duties. She also imputed into them high moral qualities such as commendable godliness, honesty, high morality, truthfulness, selflessness, being accommodating and generosity.

Kenny's Likes

Honesty is her best policy. She also likes empathy and openness.

Her Dislikes

Lies, bitterness and anything evil.

Mallam's Final Words on His Heartthrob

"If I didn't marry such a woman, I don't really know what would have happened to me. Would I have come this far in this profession or be so generous if she kept refusing me? She gave me rest of mind, opportunities to spread my wings and fly – even soar by burying her career for my own light to shine brighter. She complemented me whilst other women compete with their husbands.

She showed me other people's areas of needs – pushed me to assist in any form I could; ranging from buying foodstuffs for people, buying WAEC/JAMB forms, paying school fees, keeping our house safe and clean, being with the kids and visiting them often – and so much more without nagging.

I miss her companionship ... she understood me like I knew the palm of my hand – because she was exceedingly patient with me, and I thank Almighty Allah for giving me with such a woman. I will forever cherish her for being a friend, confidant, wife and mother."
