



#### The Genesis of a General

Dr. Obiora was born in Nnokwa, Idemili South Local Government Area of Anambra State of Nigeria on July 18, 1963. He attended Central School Nnokwa and Oraukwu Grammar School both in Anambra State.

#### Journey to Lagos Beginning of Greatness

Chukwuka's education came to an abrupt end after his secondary school because his father had no money to send him to the university—but destiny had a separate

cated to Lagos in 1980 to serve as a trade apprentice of his maternal cousin, Chief LNC Uzoezie from Alor who trained him the rudiments and styles of business (specialising in lady's shoe selling) in a make shift shop at Balogun Market in Lagos. On the 4th of March 1983, he was settled with 5,000 naira by his master to start his own business. What a relief! But the freedom was short lived; the business died in his teething stage with the demolition of "illegal shops" in 1984, by the then Military Government of General Buhari/ Idiagbon regime.

#### **The Turning Point**

Smart Chukwuka, despite the advice of his 'Oga' to look for another shop nearby, sold what was left of his shoe business at discounted rates for N10,000 and became a pharmaceutical

That business later morphed into Caleb Pharmaceuticals Ltd Lagos, and then Greenlife Pharmaceuticals Limited.

Greenlife Pharmaceuticals (with its subsidiaries) has employees' strength running in hundreds (most of them graduates), Greenlife started business with just three products when registered in 2000 now has about 20 NAFDAC registered products including Lonart antimalaria drug. It was one of the first pharmaceutical companies in Nigeria to sign on to the anti-counterfeiting technology introduced by NAFDAC in 2011 with its flagship anti-malarial drug, Lonart.


He is also Eziafakaego of Nnokwa, Nanka and many other towns.


"Chief Obiora is a very focused person. He was never distracted from his goals in life - not by circumstances because





one in six people living with disability, ensuring that cities around the world are accessible to all is vital. But which cities are doing its best, and how?

What do disabled travellers look for when choosing a city to visit? This is important not only to the disabled people, but also for the cities tapping into a large and growing accessible travel market.

In 2018 alone, the value of the so-called "purple pound" (the spending power of disabled people) to UK tourism was estimated at £15.3bn; while 27 million travellers with disabilities in the US took 81 million trips and spent \$58.7bn (£45.8bn) in that same year. As tourism recovers from the ravages of Covid-19, the business case for not excluding the 1.3 billion people living with disability one-sixth of humanity has become even more compelling.

A wide-ranging survey by the **Valuable 500** of 3,500 PWD in five countries – the US, UK, Australia, China and Japan – around their travel habits a n d experiences provides invaluable insight into this

barriers to travel for people with disability (PWD), but respondents were also asked to nominate the cities they found most accessible and why, from which a top 10 was compiled.

The resulting data provides great understanding into what makes a city attractive to disabled travellers, from the range of accessible accommodation to the availability of accessibility information. Here are four top cities for PWD to visit.



#### Singapore

Singapore has always been an easy travel destination for many compared with much of Asia, partly due to the excellent infrastructure and amenities, and partly because English is the lingua franca. But as a disabled traveller, it's the high degree of accessibility that makes it especially attractive.

In Singapore, the question "What is is not, accessible?" but rather, "What isn't?"

A majority of survey respondents nominated Singapore due to its accessible public transport, which makes

getting around the city a breeze. Unlike most underground metros, there is level access to every carriage on Singapore's MRT, which affords wheelchair users and people with impaired mobility both independence and dignity. In addition, more than 95% of pedestrian walkways, taxi stands and bus shelters are accessible to people living with a variety of impairments, and more than 85% of public buses are wheelchair-accessible. Deaf and hearing-impaired public transport users are also well catered for: as deaf resident Adrian Yapı remarked, "Whenever there is any announcement on the trains, we can see the instructions\_written\_on\_the

screen." Yap also noted that "train officers are well trained to communicate with deaf people."

According to a respondent, "While infrastructure is one thing, another major aspect that makes a big difference for mobility-challenged persons are the people of Singapore and their culture. Always smiling, welcoming, helpful and soft-spoken, they make a big difference for PWD to feel accepted and looked after."

#### Las Vegas

The visitor economy - not just tourism, but also the enormously valuable MICE market – is all-important to Las Vegas. Tourism accounts for 20% of Las Vegas' GDP (compared with a national average of 6%) and 30% of jobs (double the national average).

Las Vegas is also home to 14
of the world's largest 25
hotels and, according to
prominent wheelchair
blogger John Morris of
wheelchairtravel.org who
said, "The city has one of
the highest concentrations
of accessible hotel rooms
and suites in the world, with
hoteliers eager to attract the
disability dollar."

#### Sydney


The majority of Sydney's main attractions, including most of the city's historic National Trust properties, which are accessible by wheelchair. The iconic Sydney Opera House has a suite of accommodations for people with access needs, including accessible performances, access programmes and tailored mobility tours. And after years of campaigning, lifts were finally installed at the Harbour Bridge four years ago.

Jones added: "The majority of the public transport system is accessible to wheelchair users, including Sydney ferries. The city's

public transport network, ferries, buses, light rail (trams) and rail, is almost wholly accessible, although assistance from





impaired visitors will benefit from wide, wellmaintained pavements with plentiful tactile ground surface indicators and Braille street signs, information pylons and digital technology.

mrovision of information about accessibility – a key requirement for PWD to plan their trip - is where Sydney also scored highly.

#### London

London also scored highly in the survey, with 57% of respondents nominating it for its accessible transport links, while almost half chose the capital because its cultural attractions have good accessibility support and facilities. Many major museums and galleries have placed a\_particular\_focus\_on



accessibility, including the British Museum, the National Gallery, the Tate Modern and the Natural History Museum. There's also a wealth of information available for PWD to plan holidays and excursions.

As a blind travel blogger, Sassy Wyatt finds London easy to get around: "I can rock up to any Tube station and use the turn-up-andgo service provided by Transport for London: a member of staff will guide me through the station and get me onto the right line, another member of staff will meet me at the other end and escort me to the exit, saving me lots of mental fatique."



here is a buzz in the home of Esther Abu, where mother and daughters have just heard about a new law that will see poor Nigerian families given loans to send their children to university.

Mrs. Abu's youngest, a teenager who speaks like she is rapping, is leaving secondary school next month. She loves computer engineering but knows that her mother, a single parent whose salary as a street sweeper hardly provides enough food for the family and has to be supplemented from alms given mostly by her church - does not have the money to send her to university.

Her eldest completed secondary school two years ago and immediately began work as a hair stylist to support the family who live in Mararaba, a congested suburb on the outskirts of Abuja.

"As a girl, I dreamed of working as a doctor," says 21-year-old Eunice.

Both now have a chance, albeit slim, of reviving their dreams, as the government says it will provide loans

to pay the tuition fees for people from such poor backgrounds. However, many questions have been raised about the scheme.

Since coming into office at the end of May, President Bola Tinubu has carried out a raft of reforms at lightning pace - ending fuel subsidies, devaluing the naira, sacking the head of the central bank and security chiefs - and his latest aims to revamp Nigeria's ailing tertiary education sector.

For decades, fees have been kept low by the government to encourage enrolment in a country where many are poor and there is a high level of illiteracy.

While medicine students at the University of Lagos in Nigeria's richest state pay just 25,000 naira (£26; \$32) per year, their peers at the University of Ghana in Accra pay 3,500 cedis (£242, \$308).

But such low fees have not been matched by government funding over time which has led to schools with obsolete equipment, overcrowded classrooms, and poor remuneration for lecturers and other staff.


An average Nigerian university professor takes home less than 500,000 naira (£570; \$725) a month, while a graduate assistant gets 160,000. These conditions have led to incessant strikes, which saw universities closed for eight months last year - the ninth stoppage in 13 years.

The strikes and lack of adequate funding have eroded confidence in Nigeria's public universities, leaving people to enrol at expensive private establishments or to study abroad, especially in Eastern Europe.

By introducing the loans, President Tinubu has given universities a free rein to increase tuition fees, which the government reckons students from poor families can now afford.

The president says the scheme will expand access to education to all Nigerians regardless






While it is hard to measure the financial background of students in public tertiary schools, many at the University of Abuja are from low-income homes.

Their education is funded by parents and guardians who are junior civil servants, private security guards and company drivers.

Combined earnings in such families are often just above the threshold, putting the loan out of reach, even though they are not well-off by Nigerian standards.

These families have already taken hits from transport



Now, they will have to deal with tuition fees which have gone up in some universities - which have been mulling increases since last year - by as much as 200%.

The loan is strictly for tuition and excludes other fees such as accommodation and food, which usually account for a higher proportion of the total cost of university.

"If they are not paying for

everything, then what is the point of it? Who will buy books, pay for hostel, feeding," asks Mrs Abu, the chatter long extinguished in her home.

"They should have made the loans available to every student," says Caleb Isaac, a self-sponsored part-time student at the National Open University in Abuja.

In his spare time, he works as a marketer for a transport company and fears a hike in fees will be hard on him.

This is not Nigeria's first attempt at a students' loan - an initial plan in 1972 by the military government crumbled because beneficiaries refused to repay, says Prof Mohammed.

"Maybe the president should have first concentrated on creating jobs," says Mrs Abu.

The lack of jobs, other fees involved and a lack of clarity about what will happen to employees who default on repayments, mean the loan does not work for her family, she says.

"Better if my daughters learn trades and get small jobs than go to school and face jail," she says.


"But what if they finish school and don't get a job?" asks Mrs Abu in a low voice that hushed the room.

It is a question been repeated across Nigeria by students and their parents since the scheme was announced.

Every year, huge numbers of graduates are pumped into Nigeria's labour market but only a few find jobs.

In the last survey, in 2020, one in three of those who wanted to work were unemployed, and millions of graduates were doing jobs below their skillset such as working as hair stylists.

Funding for education has improved recently but it still falls short of the UN-recommended 15-20% of the annual national budget

[6] Every one of our 42 states must target generating at least \$2bn in export revenue. Any state government that attracts inward investment to the tune of \$1bn, will get a corresponding grant from the federal

government.


[7] Any state that fails to generate as much revenue as it spends for two consecutive years as from 2020, will be subject to an immediate declaration of a state of emergency. It shall be administered centrally by the federal government until its books are balanced.

[8] Every state must seek to generate at least 30% of its internal revenue from manufacturing and services, with a migration away from primary products to value a d d e d production.

[9] Every state is free to create more local governments provided they meet the necessary criteria which includes holding a referendum and the fact that the local government area is self-sustaining. To be recognised as a local government area, basic facilities that must exist within the domain include 20 primary schools, five secondary schools, a local government headquarters, at least

one vocational training college and at least one public health centre.


[10] All local and state governments will as a matter of course award supply contracts to companies that manufacture products within Nigeria. Only as a last resort will companies that manufacture products abroad be granted government contracts.

FR (born 2 July 1991), known professionally as Burna Boy, is a Nigerian singer, songwriter and record producer. He rose to stardom in 2012 after releasing "Like to Party", the lead single from his <mark>debut studio a</mark>lbum L.I.F.E (2013). In 2017, Burna Boy signed with Bad Habit/Atlantic Records in the United States and Warner Music Group internationally. His third studio album Outside (2018) marked his major-label debut.

In 2019, he won Best International Act at the 2019 BET Awards, and was announced as Apple Music Up Next artist that year. His fourth studio album, titled African Giant, was released in July 2019. It won Album of the Year at the 2019 All Africa Music Awards and was nominated for Best World Music Album at the 62nd Annual Grammy Awards. He was awarded African Artiste of the Year at the 2020 Ghana Music Awards. Burna Boy released his fifth studio album, Twice as Tall, in August 2020. It won Best World Music Album at the 63rd Annual Grammy Awards. He won Best International Act at the 2021 BET Awards.

Burna Boy's sixth studio album, Love, Damini, was released in July 2022 and became the highest debut of an African album on the Billboard 200 chart. It also became the highest charted African album in the Netherlands, United Kingdom and France, Burna Boy was also awarded the Member of the Order of the Federal Republic plaque for his achievements in music.

In 2023, Rolling Stone ranked him number 197 on its list of the 200 greatest singers of all time. Burna, Boy won Bet International Act at the 2023 BET Awards, making for his third win in the category.

Damini Ebunoluwa Ogulu was born on the 2nd day of July 1991, in Port Harcourt, Rivers State, Nigeria. His mother, Bose Ogulu, worked as a language translator and his father, Samuel, managed a welding company. His maternal grandfather Benson Idonije once managed Fela Kuti. His mother later became his manager. Ogulu grew up in Southern Nigeria and began making his own beats using FL Studio. He attended, Corona Secondary School in Agbara, Ogun State, and relocated to London, England to further his studies. On June 10, Burna Boy hosted Pepsi's 2022-23 UEFA Champions League Final opening ceremony in Istanbul, Turkey, along with Brazilian singer Anitta and the swedish Dj Alesso.



<mark>he Federal Aviation</mark> Administration has certified for testing a <mark>vehicle that a</mark> California start-up describes as a flying car — the first fully electric vehicle that can both fly and travel on roads to

receive US government approval.

Alef Automotive said that its vehicle/aircraft, dubbed the "Model A," is the first flying vehicle that is drivable on public roads and able to park like a normal car. It also has vertical take-off and landing capabilities. It apparently will be able to carry one or two occupants and will have a road-range of 200 miles and a flying range of 110 miles.

The company expects to sell the vehicle for \$300,000 each with the first delivery by projected for the end of 2025.

The FAA confirmed that it has issued the company a special airworthiness certificate, allowing for limited purposes that include exhibition, research and development.

Numerous companies are working on all-electric VTOLs, which stands for vehicle take-off and landing aircraft. The FAA said that Alef is "not the first aircraft of its kind" to get a special airworthiness certificate. go on roads.

However, Alef noted that its vehicle is different because of its ability to function both on roads and in the air, to appear like a normal car and to park in a normal parking space.

We're excited to receive this certification from the FAA. It allows us to move closer to bringing people an environmentally friendly and faster commute, saving individuals and companies hours each week. This is a one small step for planes, one giant step for cars," said Jim Dukhovny, the CEO of Alef.

The company's website said the flying car will be a certified as a "low speed vehicle," which means it won't be able to go faster than about 25 miles per hour on a paved road. "The assumption is that, if a driver

needs a faster route, a driver will use Alef's flight capabilities," the

company posted on the site.

Regardless, it also still needs approval from the National Highway Traffic Safet Administration

Development has been underway on the vehicle since 2015. Four friends, Constantine Kisly, Pavel Markin, Oleg Petrov and Dukhovny, inspired by the "Back to the Future" movies (which foresaw flying cars being available in that year), decided to form a company to try to develop them.

According to the company, an linitial automated test flight of a skeleton version of the car was successfully conducted in 2018, land a full-size prototype was Iflown the following year. But Alef said that it needed the FAA's special airworthiness certificate to continue conducting the necessary research and development.

The company also said that earlier this year that it had taken refundable pre-orders for more than 400 of the vehicles, with the cost of \$150 to be in the general queue and \$1,500 for the priority queue.






e Jiankui, the Chinese scientist who sparked global outrage in 2018 when he revealed that he had created the first gene-edited children, has put forward a new proposal for modifying human embryos that he claims could help aid the ageing population."

He, who in 2019 was sentenced to three years in prison in China for "illegal medical practices," relemerged last year and surprised the global scientific community when he announced on social media that he was opening a research lab in Beijing.

Since that time, updates on his research posted on his Twitter account have focused on proposed plans to develop gene therapy for rare disease. He recently posted a new research proposal that

erts sav reminiscent of his earlier work, which scientists broadly decried as unethical and dangerous - with the potential to impact human

In a succinct one-page document, he proposed research that would involve gene-editing mouse embryos and then human fertilized egg cells, or zygotes, in order

DNA across generations.

to test whether a mutation "confers protection against Alzheimer's disease."

"The ageing population is of grave importance as both a socioeconomic issue and a strain on the medical system ... Currently, there is no effective drug for Alzheimer's disease," he wrote in an apparent nod to China's growing demographic burden due to a rising proportion of elderly. Unlike the science that landed him in jail, this potential experiment linvolves a kind of abnormal fertilized egg cell generally considered not suitable to be implanted in a woman.

No human embryo would be implanted for pregnancy and "government permit and\_ethical\_approval" were required before experimentation, the proposal said.

It's not clear whether He would get approval for such work in China, even if the proposal he put forward were deemed to have merit - and other experts have said the current proposal is not scientifically sound.

Authorities in China took multiple steps to tighten rules and ethical standards affecting human gene editing in the wake of the revelations about his previous research. They also banned He from engaging in work related to assisted reproductive technology

services and placed limits on his work with human genetic resources, according to state media.

But the scientist's release of a new proposal involving gene editing of embryos has scientists and medical ethics experts concerned – and confused.

"The whole thing is, to put it bluntly, insane," said Peter Dröge, an associate professor at the Nanyang Technological University in Singapore, who focuses on molecular and

biochemical genetics.

The proposed research could be seen as a step to explore if such a method of genetic lediting could be used in al viable embryo in future, according to Dröge.

Apart from ethical considerations, gene-editing an embryo to address a complex disease that affects people toward the end of their life and doesn't have a clear, single genetic cause is "highly questionable," he said.

"He basically wants to genetically modify the human species so they don't get Alzheimer's," he said. I"I'm really surprised that he's coming forward with this again."

Joy Zhang, founding director of the Centre for Global Science and Epistemic Justice at the University of Kent in Britain, said the proposal seemed to be "more of a publicity stunt than a substantiated

## **Harvard-trained Economist** May Become The Next China Central Bank Governor

hina has named an economist who studied Cambridge University and Harvard University to a key political post at its central bank that could position him to eventually replace governor Yi Gang.

Pan Gongsheng was appointed Saturday as the new Communist Party chief at the People's Bank of China (PBOC), in a surprise move as Beijing bolsters its drive to arrest the country's economic slowdown and stem a slide in its currency.

The announcement came just days before US Treasury Secretary Janet Yellen is

expected to visit Beijing, and Ifollows a series of downbeat economic data that has sent the yuan tumbling towards levels last seen 15 years ago. Pan, who will turn 60 this week, is likely to be named governor of the PBOC following his promotion to the

top party post at the bank, state-owned Securities T i m e s reported, citing anonymous analysts.

If that happens, he will replace Yi, 65, who has been serving as the central bank's governor for five years and is still in post.

Pan currently serves as the deputy governor of the PBOC. He also holds a concurrent post as head of China's foreign exchange regulator, managing the world's largest foreign exchange reserves worth \$3.18 trillion.

He replaced Guo Shuqing, who had been the party boss at the central bank since 2018 and oversaw a regulatory crackdown on fintech conglomerates like Ant Group.

YD outpaced Tesla in the second quarter as the Chinese carmaker posted record sales of hybrid and electric vehicles.

Between April and June, BYD (BYDDE) sold more than 700,000 vehicles, almost double the number sold in the same quarter last year and setting a new quarterly record.

Recently, Tesla (TSLA) announced it had achieved its best quarterly results. The company produced nearly 480,000 vehicles and delivered over 466,000.

In June, BYD, which is backed by Warren Buffett, sold a total of 253,046 new energy vehicles, up 89% from a year ago, according to a company filing released Sunday. It was the best monthly sales

it has ever achieved. New energy vehicles include both battery powered EVs and plug-in hybrids.

Tesla and BYD are among the bestselling Electric Vehicles (EV) makers in the world. BYD still lags behind Tesla\_globally\_in terms of pure EV sales. But in China, the Shenzhen-based company has raced ahead as the top brand.

In May, BYD sold around 119,000 pure EVs, more than double from the same period last year.

In comparison, Tesla's Shanghai Gigafactory delivered 77,695 vehicles in May, up 142% from a year ago, according to the most recent statistics released by the China Association of Automobile Manufacturers.


## Australian Firm Sues Twitter for \$665,000 Bills Default

n Australian project management firm has filed a lawsuit against Twitter in a US court seeking cumulative payments of about A\$1 million (\$665,000) over alleged non-payment of bills for work done in four countries, court filings showed.

Sydney-based private company Facilitate Corp on June 29 filed the suit in the United States District Court for the Northern District of California claiming breach of contract over Twitter's failure to pay its invoices.

The Australian firm's lawsuit is the latest alleging non-payment of bills and rent against Twitter (TWTR) since Elon Musk bought the social media platform for \$44 billion last year.

F+cilitate Corp said from 2022 through early 2023, it installed sensors in Twitter's offices in London and Dublin, completed an office fit-out in Singapore and cleared an office in Sydney.





aspartame was approved for use in the United States, the sweetener's safety is getting another look by global health bodies assessing its potential links to cancer.

The World Health Organization's International Agency for Research on Cancer analysed the potential carcinogenic effects of the sweetener this month. A separate WHO and United Nations committee, the Joint Expert Committee on Food Additives, is now updating its risk assessment, including what it considers to be an acceptable daily intake.

Aspartame is a common sweetener used in beverages Coke, Sprite Zero, Pepsi Zero Sugar and Mountain Dew Zero Sugar. It's also found in chewing gum, cough drops and even some toothpastes, amona other products. The sweetener has been reviewed multiple times by the US Food a n d Drug Administration, which says aspartame is safe for the general population.

The FDA updated its website on aspartame and other sweeteners ahead of the WHO analysis; it says it monitors the latest science and levels of consumer exposure to sweeteners and calls aspartame "one of the most studied food additives in the human food supply."

made up of independent health experts from around the world. The International Agency for Research on Cancer looked at existina research to assess whether aspartame is hazardous, and the report from the Joint Expert Committee on Food Additives will provide recommendations for how much aspartame a person can safely consume.

The cancer research committee's range of carcinogens is broad, according to Qi Sun, an associate professor of nutrition and epidemiology at Harvard's T.H. Chan School of Public Health. For example, it considers mobile devices "possible carcinogens," he said, a classification that indicates that a product has "limited" links to cancer in humans. But Sun says consumers

don't necessarily need to be worried. Whether aspartame can be considered a carcinogen "boils down to what kind of evidence we have," he said.



### Vietnam Bans 'Ba Movie Over Sou

ietnam has banned Warner Bros.' highly anticipated film "Barbie" from domestic distribution over a scene featuring a map that shows China's unilaterally claimed territory in the South China Sea, state media reported on Monday.

The U-shaped "nine-dash line" is used on Chinese maps to illustrate its claims over vast dreds of the South China Sea, including swathes of what Vietnam considers its continental shelf, where it has awarded oil concessions.

"Barbie" is the latest movie to be banned in Vietnam for depicting China's controversial nine-dash line, which was repudiated in an international arbitration ruling by a court in The Hague in 2016. China refuses to recognize the ruling.

In 2019, the Vietnamese government pulled DreamWorks' animated film "Abominable," and last year it banned Sony's action movie "Unchartered" for the same reason. Netflix also removed an Australian spy drama, "Pine Gap," in 2021.

"Barbie," starring Margot Robbie and Ryan Gosling, was originally slated to open in Vietnam on July 21, the same date as in the United States, according to state-run Tuoi Tre newspaper.

Danish research postulated that people who identify as transgender have significantly higher rates of suicide and suicide attempts compared with the rest of the population, according to a population-level study out of Denmark.

The study of more than 6.6 million people found that those who identified as trans had 7.7 times the rate of suicide attempts and 3.5 times the rate of suicide deaths than the proader Danish population.

Among the 3,759 survey participants who identified as transgender, there were suicide attempts and 12 suicides between 1980 and

2021. However, the numbers are probably significant undercount, as the researchers say the records they used do not always capture person's gender identity.

The authors of study, the

published in the Journal of the American Medical Association, are careful to note that it has limitations. It can only count the number of suicides among people who have sought care from a hospital for gender identity-related medical issues, and it can only capture the number of trans people who applied for a legal | change of gender. It does not <u>detail what percentage of the</u>

population may be missed.

The study also does not pin down exactly why trans people face a higher suicide risk, but the researchers theorize that part of the problem may be "minority stress," in which people are bullied, discriminated against, socially excluded or faced with general prejudice for who they are. The researchers say previous work has showed that 60% of transgender people in Denmark experienced abuse in the form of harassment or bullying, and 30% experienced physical violence. Trans people in Denmark also report that they face discrimination in their interactions with the health care system.

The researchers also note that the work may not reflect the situation in other countries.

The Girls' Education Programme Phase 3 (GEP3) and Sustainable Development Goal 4 of the United Nations were aimed at improving access, enrolment, retention, and learning outcomes for girls in basic education in Northern Nigeria, particularly in Bauchi, Katsina, Niger, Sokoto, Zamfara, and Kano states

According to the factsheet presented at the national dissemination meeting of the final evaluation of GEP 3 and SDG 4 conducted between the years under review by Senior Education Manager, UNICEF Michael Banda, the search project was premised on related educational policies of the federal and state governments.

The factsheet revealed that before the coming of the GEP 3 project, one in four children in Nigeria were out of school, most were girls located in the North

West and North-east and in 2021, girls' primary attendance rate was 66 per cent compared to boys at 72 per cent.

The document indicated that about 1.5 million girls enrolled in school (surpassing the target of 1 million girls) and increased enrolment of girls by household while 23,655 girls benefited from the cash transfer programme to enable them to stay in school.

2.6 million children continued education through alternate learning during COVID-19; back-to-school campaigns were conducted in 18,567 schools, resulting in 94% of children returning to school.

Over 67,000 teachers and Integrated Quranic Studies (IQS) facilitators were trained; teaching competency improved from 12% to 52%

Over 3,800 schools and IQS implemented RANA with improvement in foundational literacy and over 135,000 girls benefited through 4,514 functioning G4G groups; school attendance improved from 43% to 70% through phases 1, 2 and 3 of the project.

## 106-year-old Filipino Becomes **Vogue's Oldest** cover model

106-year-old tattoo artist from the Philippines, Apo Whang-Od, is Vogue's oldest cover model as revealed in the popular magazine's cover of April

Whang-Od — also known as Maria Oggay — has been perfecting the art of hand-tapping tattoos since she was a teen, learning under her father's instruction.

Residing in the mountain village of Buscalan, about 15 hours north of Mahila, in Kalinga province, she is considered the country's oldest mambabatok — or traditional Kalinga tattooist.

Once, the hand-tapped tattoos that Whang-Od creates using just a bamboo stick, a thorn from a pomelo tree, water and coal, were earned by indigenous Butbut warriors.

Now, international visitors seeking her signature geometric designs make up much of her clientele.

Whang-Od, the last mambabatok of her generation, has imprinted the symbols of the Kalinga tribe signifying strength, bravery, and beauty — on the skin of thousands of people who have made the pilgrimage to Buscalan.



## World's largest 'wood city' to be built in Stockhol.

n recent years, wooden buildings have reached new heights, with soaring timber skyscrapers completed or underway in countries like Norway, Switzerland and Australia.

Meanwhile, Singapore can lay claim to the largest timber building in Asia with a sprawling 468,000-square-foot college campus that opened in May.

Now, real estate developer Atrium Ljungberg has announced plans to build the world's largest "wooden city," which will be constructed in Sweden's capital, Stockholm, from 2025.

Stockholm Wood City will

feature 7,000 office spaces and 2,000 homes in the city's southeast, and will offer a vibrant, urban environment with a mix of workplaces, housing, restaurants and shops set across 250,000 square metres, which will be the "world's largest known construction project in wood."

The project is being built in Sickla, a neighbourhood already home to more than 400 companies. Stockholm Wood City will be the largest timber construction project in the world.

Although some experts have raised concerns over fire risks posed by wooden buildings, but advocates argue that engineered timber burns at a relatively slow and predictable rate, making it safer than many conventional steel structures.

Timber is also a "carbon sink," meaning that carbon dioxide removed from the air by trees is stored in the material rather than being returned to the atmosphere.

Wooden buildings have been found to enjoy better indoor air quality and can be constructed with significantly lower carbon emissions than those made with conventional materials.

The new app is the latest chapter in the rivalry between Facebook boss Mark Zuckerberg and Elon Musk, who bought Twitter in October.

In June the two high-profile billionaires – agreed to take each other on in a cage fight in an exchange that went viral on social media.

The arrival of the new app comes after Twitter announced TweetDeck is to become the next part of the company to be limited to users who have paid for verified status.

The application, which allows users to manage multiple feeds and searches, will only by accessible to verified users in 30 days, according to a tweet from Twitter Support on Monday evening.

A new version of TweetDeck has been made available with the tweet giving instructions to update. The announcement follows Mr Musk announcing two days earlier that users were being limited to reading 600 posts a day.

# CATHOLIC CHURCH CALLS FOR NTERVENTION IN SUDAN

outh Sudan's Catholic bishops are calling for urgent intervention by the international community to help resolve the conflict in neighbouring Sudan and to provide humanitarian assistance to the needy in the region.

A letter signed by eight bishops, addressed to the government of South Sudan, the international community and humanitarian agencies, called for provisions of aid both within Sudan and in South Sudan - and in other neighbouring countries which are hosting Sudanese refugees.

They said in order to reduce the suffering of the people of Sudan, the way forward is a peace process not war.

"We are deeply concerned about the regional and international components to the conflict [in Sudan]. The conflict is destabilising the already fragile region, weakened by internal conflicts," the bishops said.

A joint effort by the US and Saudi Arabia to broker ceasefires has had limited success. A regional African mission to find peace has so far not made any progress.

Over 130,000 people have fled the fighting and crossed into South Sudan. Most were returning citizens but among them are 10,000 Sudanese refugees, according to a UN estimate.

Most Sudanese refugees now reside in Egypt and Chad.
